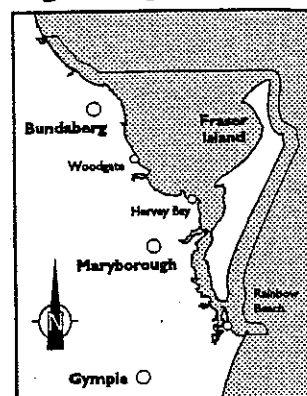
The Panel found Mr Wright guilty of a disciplinary charge that he is not a fit and proper person to be a registered professional engineer.

PUBLIC NOTICE**Area of interest for
Queensland Marine Park
- Great Sandy Region**

In accordance with section 12 of the *Marine Parks Act 1982* the Minister for Environment, Dean Wells, has defined an area of interest for declaration as a Queensland Marine Park.

The area is described as tidal lands and tidal waters of Queensland within the northern section of the Great Sandy Region. The western boundary extends south along the Highest Astronomical Tide (HAT) of the Queensland coastline from latitude 24°30' S (the southern boundary of the Great Barrier Reef Marine Park) to Double Island Point at latitude 25°57' S, including Tin Can Bay and Inlet, and extends three nautical miles seaward of the mainland and Fraser Island. The area is enclosed by an east/west boundary line drawn between the three nautical mile limits east of the mainland and north of Fraser Island.



Submissions are hereby invited from members of the public or of interested groups concerning:

- (a) the suitability of the area for the purposes of a marine park;
- (b) the desirability of declaring a marine park in respect of the area;
- (c) the appropriate boundaries of any marine park declared in respect of the area;
- (d) the zoning requirements appropriate to any marine park declared in respect of the area; and
- (e) the appropriate provisions for management of any marine park declared in respect of the area and of any zones of that park.
